
Notice of Study Completion Municipal Class Environmental Assessment Fergus Golf Club Redevelopment

The Study

Fergus Development Inc. has completed a Municipal Class Environmental Assessment (MCEA) Study to evaluate alternatives for water and wastewater servicing required for the redevelopment of part of the Fergus Golf Club lands. The preferred design concept for wastewater servicing is the Aerobic Foam Media Trickling Filter. The preferred design concept for water servicing includes primary disinfection by UV, aesthetic treatment for hardness via softening membranes and above ground water storage.

The Process

The project was conducted in accordance with the planning and design processes for 'Schedule C' projects, as outlined in the Municipal Class Environmental Assessment (2023), which is approved under the Environmental Assessment Act.



The MCEA process includes consultation with agencies, stakeholders, Indigenous communities and public; an evaluation of alternative solutions to address the problem; alternative design concepts for the preferred solution; an assessment of potential environmental impacts; and identification of reasonable measures to mitigate any potential adverse impacts. A Notice of Study Commencement and Public Information Centre #1 inviting public input was published on May 18, 2023 and the first of two Public Information Centres (PIC) was held on June 1, 2023. The second PIC was held on September 11, 2023.

Environmental Study Report

An Environmental Study Report (ESR) has been prepared to document the planning and decision-making process for this Study. By this notice, the ESR is being placed on the public record and will be available for a 30-day review period starting April 25, 2024, and ending May 24, 2024 to meet requirements of the MCEA process.
